District and Sodexo shall work together to ensure a financially sound operation and shall guarantee financial results for the 2009-2010 school year as follows:

Surplus Guarantee

Sodexo guarantees that District shall receive an annual financial return of Six Thousand Seven Hundred Twenty Dollars (\$6,720.00) for the 2009-2010 school year. If the annual financial return for the Food Service Program falls short of the aforementioned amount, Sodexo shall pay the difference to District in an amount not to exceed one hundred percent (100%) of Sodexo's annual **Management Fee**. Sodexo reserves the right to recover any such reimbursement made during the current contract year from that year's Surplus on a monthly basis.
